## TOWN OF FINE

## LOCAL LAW

A local law providing for the appointed office of assessor for the town of Fine.

Became a law January 1, , 1980, no petition protesting.

Passed by the local legislative body of the town of Fine. Filed in the office of the secretary of state February 12th , 1980.

Be it enacted by the town board of the Town of Fine as follows:

Section 1. Pursuant to Real Property Tax, Article fifteen-A, from and after  $\underline{\hspace{0.5cm}}$  January 1,  $\underline{\hspace{0.5cm}}$ , 1980, there shall be in the town of Fine but one assessor, to be appointed by the town board.

Section 2. Upon the establishment of the office of appointed assessor by this local law, the terms of office of all assessors then in office shall terminate.

Section 3. This local law shall be subject to a permissive referendum as prescribed by the Municipal Home Rule Law.

Section 4. The effective date of this local law shall be governed by the Municipal Home Rule Law and shall be no earlier than January 1, , 1980.
