Local Law No. 1 of the Year 2023

A local law repealing Local Law Number 4 of the year 2011 and Changing Grievance Day.

Be it enacted by the Town Board of the
(Name of Legislative Body)

Town of Fine as follows:

Local Law Number 4 for the year 2011 is hereby repealed and the following enacted in its stead:

Section 1. The purpose of this law is to provide for a change of grievance day in the Town of Fine to a date other than the fourth Tuesday in May, due to the fact that the Town of Fine shares an assessor with other taxing jurisdictions.

Section 2. Grievance day is defined as the day for hearing of complaints on assessments in accordance with §512 of the New York Real Property Tax Law.

Section 3. The Town of Fine hereby establishes Grievance Day to be held on the first Wednesday immediately following the fourth Tuesday in May in each and every year.

Section 4. This Local Law shall be effective upon the date of filing with the Secretary of State pursuant to Section 27 of the Municipal Home Rule Law.

Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or, if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto local laws or ordinances.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. ____ of 20__, of the City of _____ having been submitted to referendum pursuant to the provisions of Section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on _____, 20____, became operative.

6. (County local law concerning adoption of Charter.)
